She employs her breadth of knowledge regarding California Proposition 65 enforcement and compliance to assist clients in negotiating resolution of Proposition 65 enforcement actions, and in developing systems to ensure compliance. She also has experience negotiating with federal and state environmental agencies on behalf of her clients in the context of hazardous waste management, air quality, soil, and groundwater cleanup.

- **San Diego Harbor Litigation and Sediment Remediation** – Regulatory and litigation counsel to a shipyard in multi-million dollar parallel administrative and federal court proceedings, including cost recovery and allocation litigation. The administrative proceedings involve a Cleanup and Abatement Order for the largest proposed sediment remediation project in the San Diego Bay, and the first site where the Regional Board required an EIR.
- **TCE Plume Liability Allocation** – Counsel to PRP group in mediation to establish liability for TCE plume, and minimize potential allocation to PRP group members. Representation includes the management of relationship of PRP group members with Regional Board, and other interested entities.
